GOAL

To enhance the provision of public service among the constituents of the barangay by providing better health services, quality education among daycare centers, and complete construction and rehabilitation of service roads/path walks in all sitios in five years in time.

OBJECTIVES

1. To upgrade the facilities of the health center of the barangay, purchase of an ambulance and access to quality but affordable medicines to all, and continue the program on sitios visitations.
2. Renovate daycare centers into a more conducive learning place.
3. Increase the level of competency of daycare teachers by providing them enough trainings and seminars.
4. To finish the construction and or rehabilitation of service roads and pathwalks in all sitios of the barangay.
5. To continuously coordinate with the sitio leaders as the implementers of all the barangay projects.
6. To keep the barangay tanods in each sitios for a more peaceful and orderly.
7. To maintain linkages among other agencies for a more sustainable development of Barangay Sta. Cruz.

Ang Barangay Sta. Cruz ay nabuo sa pinagsamang-samang mga Sitio ng Barangay Dela Paz. Ito ay ang mga Sitio ng Sta. Cruz, Nagpuso, Cavaliers, Kay Baiya, Mahal na Poon, Tawid-Tawid, Uulan, Makatubong, Mini, Tagisan at Seven Hill. Initala ang mga pinagsama-samang Sitio na Barangay Sta. Cruz at pinagtibay naman ng Batas Pambansa Bilang 791 noong Abril 21, 1984.

Si Kgg. Jesus Gonazales ang unang Punong Barangay ng Barangay Sta. Cruz na nanungkulan mula 1992 at si Kgg. Ma. Herra M. Domingo ang pumangalawa mula 1994. Ang pangatlong Punong barangay ay si Kgg. Rina G Junio na nanungkulan mula 1994 hanggang Nobyembre 30, 2007. Ang pang-apat at kasalukuyang Punong Barangay ng Brgy. Sta. Cruz ay si Kgg. Oscar "Oca" T. Tamayao na nagsimulang manungkulan noong Disyembre 1, 2007.

BATAS PAMBANSA BILANG 791*

BATAS PAMBANSA BLG. 791 - AN ACT CONSTITUTING SITIOS OF STA. CRUZ, NAGPUSO, CAVALIERS, KAY BAIYA, MAHAL NA POON, TAWID-TAWID, UULAN, MAKATUBONG, MINI, TAGISAN AND SEVEN HILLS, ALL IN BARANGAY DELA PAZ, MUNICIPALITY OF ANTIPOLLO, PROVINCE OF RIZAL, INTO A NEW BARANGAY TO BE KNOWN AS BARANGAY STA. CRUZ.

SECTION 1. The sitios of Sta. Cruz, Nagpuso, Cavaliers, Kay Baiya, Mahal na Poon, Tawid-Tawid, Uulan, Makatubong, Mini, Tagisan, and Seven Hills all in Barangay Dela Paz, Municipality of Antipolo, Province of Rizal, are hereby separated from Barangay Dela Paz and constituted into a new barangay of the said municipality to be known as Barangay Sta. Cruz.

SECTION 2. The Barangay Sta. Cruz shall include the area bounded on: N - Marcos Highway, S – Sumulong Highway, E – Olalia Rd., Brgy. Dela Paz, W – Brgy. Mambugan to Marcos Highway near Nangka River.

SECTION 3. After ratification by the majority of the votes cast in a plebiscite to be conducted in the area affected within one hundred twenty days from the approval of this act, the President of the Philippines shall appoint the first officials of Barangay Sta. Cruz who shall hold office until their successors shall have been elected and qualified in the next regular barangay election.

SECTION 4. The commission on election shall conduct and supervise the plebiscite herein provided. The expenses for such plebiscite shall be charged to the appropriations of the Commission on Elections provided in the current Annual General Appropriations Act for plebiscites.

SECTION 5. This Act shall take effect upon its approval.
